## Rules & Regulations:

- Fees: \$15.00 regular classes \$25.00 Championship, Medal and Challenge Classes  
\$20.00 Post Entry Fee (per horse) postmarked date after Wednesday, August 9, 2017  
\$15.00 Office Fee per Horse/Pony (includes MHA \$4/horse, pony & number fees)
- Any entries incurring bank fees will be charged \$30.00 plus cost of the fee and the original bill.
- Refunds will be made upon receipt of a vet certificate (or Dr.) and must be received by the show manager before the end of the show.
- Every Class recognized by NEHC & MHA will be conducted and judged under the current rules of NEHC & MHA. NEHC rated class specifications can be read in the current NEHC Rule Book; MHA pointed class specifications can be read in the current MHA Rule Book.
- Six ribbons/trophies/premiums awarded per class. All vouchers are the responsibility of the winner when given. They must be turned in after your last class and are not valid after the show office closes on August 13, 2017.
- Premium distribution: **\$100** - \$40, 25, 15, 10, 5, 5; **\$75 classes** - \$25, 20, 12, 8, 5, 5; **\$45 classes** - \$15, 12, 10, 8
- Lunch break will be announced. Hot Diggity Dog will be on the grounds
- The Pine Tree Sizzler Show Committee, its agents or employees, or the Hollis Equestrian Park will not be responsible for any accident which may occur to rider, groom, attendant, spectator, animal, or equipment at the show. Nor will any of the aforementioned be held responsible for loss or destruction of any property or equipment or damage to or by animals at the Show or on the grounds.
- **WARNING:** Under Maine State Law an equine professional has limited liability for an injury or death resulting from the inherent risks of any equine activities.
- Post entries must be made a minimum of 3 classes prior to the entered class.
- No dogs on the show grounds unless kept on a leash away from the ring.
- No alcoholic beverages will be permitted on the show grounds.
- **PROOF** of current rabies, negative Coggins, record of vaccinations (Rhino, Influenza, EEE, WEE, etc) and registration papers (breed classes) will be required to show.
- All users of the Hollis Equestrian Park understand that Friends of the Hollis Equestrian Park and the Town of Hollis are to be held harmless for all events and issues resulting from or associated with the use of the park. These events/issues include, but are not limited to, the cost of loss, damage, accidents, or legal expenses.

### Getting to the Hollis Equestrian Park:

#### From the South via the Maine Turnpike:

Take Exit 25 (formerly Exit 3) in Kennebunk. Follow the signs to Route 35 North. Stay on Route 35 through Kennebunk and Lyman. Turn left on Route 5 at Dayton. Park is 2.5 miles on the left.

#### From the North via the Maine Turnpike:

Take Exit 46 (formerly Exit 7B) in South Portland. Turn left out of the toll booth and then left onto Route 22 West. Take Route 22 Through Westbrook, Scarborough, Gorham and into Buxton. Turn left on Route 202 South into Hollis Center. Turn left, heading South, on Route 35. Turn right on Clark's Mills Road. At the end of Clark's Mills Road, turn left on Route 5. Park is immediately on your right.

#### From Route 202 (Sanford area):

Turn right, heading South, on Route 5 in North Waterboro. Continue right on Route 5 toward Saco. Park will be on your right, approx. 1 mile from where Route 5 and Route 202 part.

#### From Route 5 (Saco area):

Drive North on Route 5 through Dayton. Park will be on your left approx. 2.5 miles North of the Route 35 intersection.

To be shown at a walk, jog/alt. gait and lope both ways of the ring. Judge may ask to extend any gait. Must be asked to back.

To be judged on manners, performance, quality, and substance.

##### Hunter Seat Pleasure Challenge

Open to horses shown hunter seat for pleasure purposes.

To be shown at a walk, trot/alt.gait and canter both ways of the ring. Must be asked to back. To be judged on manners, performance, quality and soundness.

##### Saddle Seat Pleasure Horse Challenge

Open to horses shown saddle seat for pleasure purposes.

To be shown at a walk, trot/alt. gait and canter both ways of the ring. Must be asked to back. To be judged on manners, performance, presence and quality.
