"Every entry at an affiliated show shall constitute an agreement and affirmation that the person making it, along with the owner, lessee, trainer, manager, agent, coach, driver, rider & the horse: (1) shall be subject to the Constitution and Rules of NEHC, MHA, the local rules of the show; (2) that every horse, rider &/or driver is eligible as entered; (3) that the owner and any of his representatives are bound by the Constitution & Rules of NEHC, the Bylaws and Rules of the Maine Horse Association Inc., and the show will accept as a final decision of the hearing committee of the NEHC and/or MHA on any question arising under said rules, and agree to hold the show, the Highview Riding Club Horse Show, the NEHC, the MHA, and their respective officials, directors and employees, harmless of any action taken; (4) that the owner, rider/driver and any of their agents or representatives agree to hold NEHC, MHA, Highview Riding Club, the show and their respective officials, directors, employees and agents harmless for any injury or loss suffered during or in connection with the show, whether or not such injury or loss resulted, directly or indirectly, from the negligent acts or omissions of said officieals, directors, employees or agents of the NEHC, the MHA, the Highview Riding Club and the show. The constitution or application of MHA rules is governed by the Laws of the State of Maine."
