Every entry at an affiliated event shall constitute an agreement that the person making it, owner, lessee, trainer, manager, agent, coach, driver, rider, groom & the horse shall be subject to the Bylaws, & the Rules of the Maine Horse Association, the rules & regulations of the show, and that every horse, rider and/or driver is eligible as entered & that the owner and any of his representatives are bound by the Bylaws and Rules of the Maine Horse Association, Inc. & the affiliated event, accept as final the decision of the MHA, or committees thereof in any question arising under said rules, and agree to hold the affiliated event, the Lupine Summer Horse Show, the MHA, and their respective officials, directors and employees, harmless for any action taken, or for any injury or loss suffered during or in connection with the show, whether or not such injury or loss resulted, directly or indirectly from the negligent acts or omissions of said officials, directors, employees or agents of MHA and the Lupine Summer Horse Show.
