<p>Every entry at an affiliated event shall constitute an agreement and affirmation that the person making it, along with the owner, lessee, trainer, manager, agent, coach, driver, rider, and the horse: (1) shall be subject to the Bylaws and the Rules of the Maine Hunter/Jumper Association (MeHJA), Maine Horse Association (MHA), and the local rules of the Show; (2) that every horse, rider, and/or driver is eligible as entered;(3) that the owner and any of his representatives are bound by the Bylaws and the Rules of the Association(s) and the Show and will accept as final the decision of the MHA, Inc, MeHJA or Committees thereof on any question arising under said rules and agree to hold the show, the MHA Inc., MeHJA and Kane Kountry Farm, SeaCoast Pony Club and agents harmless for any action taken; (4) that the owner, rider/driver and any of their agents or representatives agree to hold the Show, the MHA Inc., MeHJA, SeaCoast Pony Club and their officials, directors, employees and agents harmless for any injury or loss suffered during or in connection with the Show, whether or not such injury or loss resulted, directly or indirectly, from the negligent acts or omissions of said officials, directors, employees or agents of Show. The constitution or application of Maine Horse Association, Inc., MEHJA rules is governed by the Laws of the State of Maine.
